Item 4. Election of Directors and Officers

At the meeting of the Board of Directors of Golden Bria Holdings, Inc. held earlier today, August 10, 2018, Ms. Joy J. Fernandez tendered her resignation, with immediate effect, as a Director and Treasurer of the Company.

Thereafter, Mr. Rizalito J. Rosales was nominated and appointed by the Board of Directors of the Company to replace Ms. Joy J. Fernandez as Director, and to serve for the remainder of Ms. Fernandez' term. The Board of Directors further resolved to appoint Mr. Rosales as the Chairman of the Compensation and Remuneration Committee to fill in the vacancy left in the wake of Ms. Fernandez' resignation.

In the same meeting, Ms. Frances Rosalie T. Coloma was appointed by the Board of Directors as the Treasurer of the Company.

Rizalito J. Rosales, *President, Bria Homes, Inc.* Mr. Rosales graduated from the Ateneo de Manila University with a degree in Bachelor of Science in Management, minor in Marketing. He attended his post-graduate studies in business from De La Salle University. He was the Managing Director for Vista Residences and Corporate Planning Officer of VLL from 2007-2016. He was also Division Head for Polar Realty from 2003-2006 and Crown Asia from 2001-2003 after holding various Marketing and Sales functions in the company since 1995.

At the meeting of the Board of Directors of the Company held earlier today, August 10, 2018, the Board approved and authorized the release of the Unaudited Financial Statements of the Company as of and for the six months ended June 30, 2018.
